### Student Account Fund Qualifications

1. A total of three (3) concessions must be worked per family, by a parent/guardian. These duties include, but are not limited to home game concessions for Junior Varsity and Varsity Football games, and Paulding Meadows.
2. The parent/guardian may work a combination of three home game concessions or two home game concessions and one Paulding Meadows concession. Only (1) of the home game concessions may be a JV or Freshman football concession. If you chose to, one spouse may work one concession while the other works another concession.
3. The parent/guardian must sign in and out on the Concession List to be eligible to receive credit for working the concessions. Please make sure to list the student(s) name for which you are working. The Concession List will be used to verify that the required concession duty has been fulfilled and a refund of the concession commitment fee is in order.
4. Should a student work a concession (i.e. Paulding Meadows) it will not be applied toward the families' three concession duties.
5. The student must participate in Individual Fundraisers.
6. Individual Fundraisers as set by the Ways and Means Committee shall be on a 50/50 Split. 50% of the profit is deemed to be held in the Individual Student's Account. The other 50% of the profit will be distributed to the General Fund account.
7. The Executive Board can approve other fundraiser to be a 50/50 Split, upon the recommendation of the Ways and Means Committee.
8. Student Account Funds are held in accordance by the By-Laws set forth, for the duration of the student's participation in the East Paulding High School Band Program.
9. Upon graduation or when the student leaves the East Paulding High School Band program, all funds held in the Individual Student's Account will revert to the General Fund Account.
10. Refund of Student Account Funds are not permissible in accordance with Federal Stipulations of 501 (3) (c) Corporations.
11. Funds held in account will not be allowed to be transferred to other students, except in the event of a sibling.
12. Upon written request, funds held in Student Account can be held for one school year (Aug-June) pending admission of a younger sibling into the East Paulding High School Band Program. Request must be made in writing by May 1st of any given school year and given to the Treasurer.
13. Student Account must be in good financial standing before account credits can be applied. Any outstanding band debt incurred will be credited first before the student begins accruing funds.
14. There is no maximum limit on the amount of Student Account Funds you can earn.
15. Disbursements will only be available for distribution upon completion of a combination of the three mandatory concession duties during a specific school year (Aug-June), per family as required.
16. Disbursement of Student Account funds will be made upon receipt of completed "Disbursement of Student Account" form.
17. Disbursements may be used for band fees, uniform fees, trip payments, spirit wear sold by the Raider Brigade, and any other honor band fees.
18. Disbursements **may not** be used for color guard flag deposits, payment for any individual or event fundraiser, or to make restitution a NSF check.
19. Student Account Funds **may not** be used outside the East Paulding High School Band Program.
