Student Account Fund Qualifications

Student Account is an account which holds funds that may be used as payment for band related activities.

- A total of two (2) concessions must be worked per family, by a parent/guardian. These duties include, but are not limited to home game concessions for Junior Varsity and Varsity Football games, Paulding Meadows, and Little Miss Raider/Miss Raider pageants.
- The parent/guardian may work a combination of two home game concessions or one home game concession and one Paulding Meadows concession. If you chose so, one spouse may work one concession while the other works another concession.
- The parent/guardian must sign in on the Concession List to be eligible to receive credit for working the concessions. Please make sure to list the student(s) name for which you are working for.
- Should a student work a concession (i.e. Paulding Meadows) it will not be applied toward the families' two concession duties.
- The student must participate in Individual Fundraisers.
- Individual Fundraisers as set by the Ways and Means Committee shall be on a 50/50 Split. 50% of the *profit* is deemed to be held in the Individual Student's Account. The other 50% of the *profit* will be distributed to the General Fund account.
- The Executive Board can approve other fundraiser to be a 50/50 Split, upon the recommendation of the Ways and Means Committee.
- Student Account Funds are held in accordance by the By-Laws set forth, for the duration of the student's participation in the East Paulding High School Band Program.
- Upon graduation or when the student leaves the East Paulding High School Band program, all funds held in the Individual Student's Account will revert to the General Fund Account.
- Refund of Student Account Funds are not permissible in accordance with Federal Stipulations of 501 (3) (c) Corporations.
- Funds held in account will not be allowed to be transferred to other students, except in the event of a sibling.
- Upon written request, funds held in Student Account can be held for one school year (Aug-June) pending admission of a younger sibling into the East Paulding High School Band Program. Request must be made in writing by May 1st of any given school year and given to the Treasurer.
- Student Account must be in good financial standing before account credits can be applied. Any outstanding band debt incurred will be credited first before the student begins accruing funds.
- There is no maximum limit on the amount of Student Account Funds you can earn.
- Disbursements will only be available for distribution upon completion of a combination of the two mandatory concession duties, during a specific school year (Aug-June), per family as required.
- Disbursement of Student Account funds will be made upon receipt of completed "Disbursement of Student Account" form.
- Disbursements may be used for band fees, trip payments, spirit wear, and any other honor band fees.
- Disbursements may not be used for color guard flag deposits, payment for any individual or event fundraiser, or to make restitution a NSF check.
- Student Account Funds may not be used outside the East Paulding High School Band Program.
